Program: Demonstration of 2 dances: Cha-Cha, and Rhumba

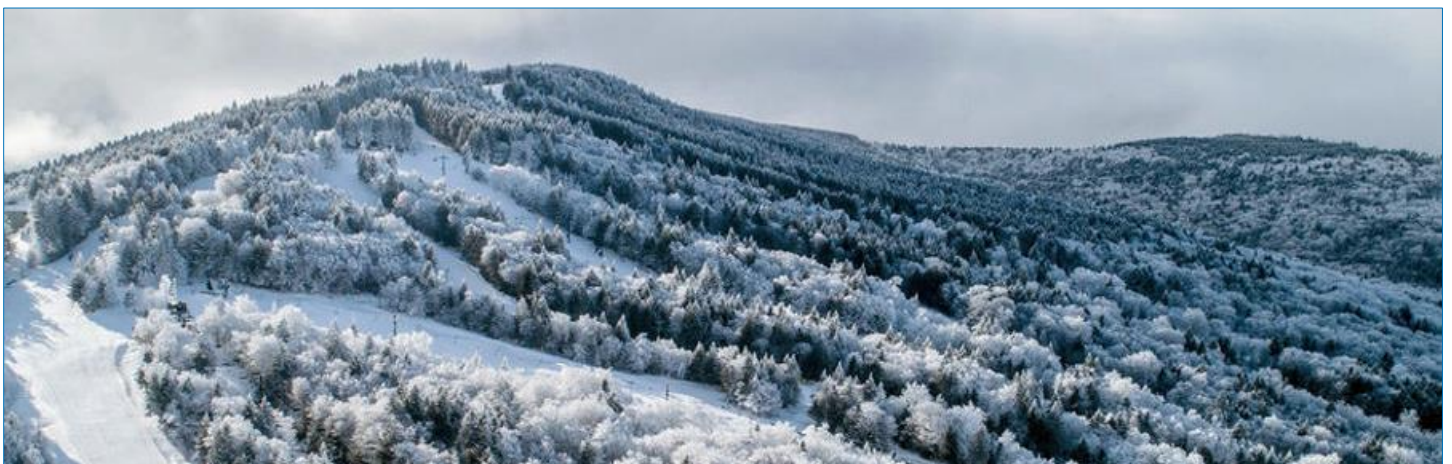

# Timberline Mountain, West Virginia

Ever since Perfect North purchased Timberline Mountain in WV, improvements can be seen and felt at the resort since re-opening in the 2020-2021 season. From the new 6-person high-speed detachable lift that takes you up to the top and the fixed grip quad lift to mid-mountain, the lines move quickly, and everyone can enjoy more time on the slopes. The snow making was enhanced with upgraded equipment which easily keeps 100% of the trails open. The grooming is similar to what you find out west. The lodge got a face-lift and new this season was outdoor decks on 2 levels. The 16-room hotel at the base of the mountain is convenient for ski-in/ski-out access. Views from the top looking over Canaan Valley are spectacular.
